

Number of Calls on Each Day of the Week during 2015




Number of Calls per Day and Night Shift during 2015

<u>Training-</u> Volunteer Reserve Cordes finishing Driver Operator 1A/1B. Looking to place him in Command courses for FAE status. List sent to training for additional Volunteer Reserves Driver/Operator course.

<u>Outgoing Correspondence:</u> Received letter from OES for WT 7759 reimbursement. Signed form and faxed back. Total of \$3,150.11

<u>County-</u> Received an email notification from County that "legacy" Administrative personnel have the option to stay on. Heather Beer was notified and is volunteering her time 1 day per week.

Emailed the County requesting the computer in the radio room be updated with appropriate operating systems and station email.

<u>Calendar-</u> Heather Beer has created a "hard copy" calendar for special events at the station. This will give awareness to station personnel of planned public events/meetings.
