

Number of Calls on Each Day of the Week during 2015



Administration:

<u>County Correspondence-</u> Captain Johnson drafted a cost estimate for the County regarding short term needs and Capital outlay for FY 2016/2017.

<u>Computer-</u>County is working on installing a computer/VPN that gives CAL FIRE personnel access to the CAL FIRE Intranet.

<u>CERT-</u> FAE Steve Chapman (CAL FIRE) continues to attended CERT meetings. In addition he is assisting La Jolla Reservation and Rey River Ranch explore the possibility of starting their own CERT program.

<u>Fire Safe Council-</u> Council is very active and keeps me informed of their progress. Representative from PMFSC will give update to Fire Board.

<u>Weather-</u> The mountain is starting to experience icy conditions. Communication with County Roads is working well for notification of road conditions.

Equipment- Inventory completed. Chief Williamson proposes some items be sold and money placed in the Fire Department account.
