Fuel reduction grant funding	<ul> <li>-California Conservation Corps (CCC) fire prevention projects for public land near habitable structures: CCC is providing crews for 6 months of work in SD County. The PMFSC submitted a proposal to the CCC to create 2 firebreaks on 1) Palomar Summit and 2) between State park and Private land. Proposal favorably reviewed. Steve Kirsch at the CCC was finalizing contracting for Palomar but is now unable to do so as his time has been substantially cut back. Proposal now on HOLD.</li> <li>- SDG&amp;E still has funding (\$2500) available for community education projects. PMFSC will apply as soon as our 501c3 status is reinstated.</li> </ul>
Evacuation Routes	-Alternative evacuation routes: No action this month. Awaiting cooler weather and less poison oak to walk the routes (1-3)
	1.Dirt track through Wall's property from Crestline to East grade is well graded and is easily passable. However, the gate at East Grade is secured with a heavy cable lock with non-standard numerical combination (SDGE).
	2. Dirt track through Borland's to Conifer Road is passable although low clearance vehicles would have difficulty. Gate at East Grade secured with a lock that would need to be cut with bolt cutters.
	3. Old road from Birch Hill to East grade would need to be cleared, graded and the final portion that drops off abruptly (6 ft) to East Grade would need modification.
	-Liaise with CAL Fire, USFS, Sheriff's Dept., PMFD, CERT, Community Center, re alternative routes from both (Birch Hill) and West sides of South Grade, evacuation instructions, provisions for post-evacuation access.
