CAL FIRE	<p>Defensible space inspection past 2 years has included 100% of habitable structures. Residents are doing a good job. Most non-responders to warning notices are trusts and LLCs. Increased enforcement this year. CAL FIRE will subcontract improvement and bill unresponsive owner.</p> <p>New Station 79 in-charge schedule: Alex Rodriguez (Engineer) & Dean Kowalski (Captain-Paramedic) will alternate Sun-Tues and Wed-Sat schedules.</p> <p>CAL FIRE "No Burn" proclamation in effect for private land.</p>
SDCo Fire	<p>New Initiative: Building Resilient Wildfire Resistant Communities. First phase, now completed, was on improving/ coordinating emergency management/ and fire response capability at the County level. Second phase will focus on working with SDC FSCs and local communities for 1) pre-emergency planning/evacuation corridors, 2) fuel reduction, and 3) structural hardening. YV attended planning meeting and also spoke at Supervisors Meeting (6/4) in support. Supervisors unanimously funded increased SDC Fire Author staff for project. This year Crest/Guatay (both have 2018 CAL FIRE Grants for fuelbreaks) first on list, Lawson Valley and Palomar are next.</p> <p>-SDC Fire Authority Community Support Program: WUI classes, Fire Station Open House, Emergency Preparedness workshop, animal/pet preparedness events, Communications/Ham radio training being offered. Michele Clock (Coordinator-SDC Fire Authority Community Support Program) will look into CEQA requirement exemption for roadside brushclearing</p>
USFS	<p>Tim Gray 1) requested public support for ongoing USFS Palomar Community Defense Zone and Fuelbreak Project (2010); 2) Described collaborative planning for the next USFS grant cycle that includes Jeff Valley and other Palomar Mountain fuelbreaks. If funded, work would begin 2021-2022 after NEPA approval process. PMFSC invited to participate: LT will be PMFSC planning representative.</p> <p>USFS at peak staffing. Two teams out in N. California. No engine at USFS PM Station - in shop for frame cracks. Henshaw USFS Station engine also in shop for repair.</p> <p>Fry Creek Cut and Pile from 2 years ago hasn't been burned due to previous rain and snow, now not good conditions for B1 (complex) burn. Plan still in place to burn N side Palomar Divide- B2 burn so as not as complex as Fry Creek and can do in less optimal conditions.</p>
FSCSDC	<p>Updated CWPP submitted. New maps to be appended. Community map needs to be corrected.</p>

PMVFD	Roadside water storage tanks: Need specification and cost for tanks/appropriate connections for NRP grant submission. LT will discuss with PM Mutual Water Company possibility and estimated cost to connect tanks on Crestline to PM Mutual Water Company lines (vs. filling prn from CAL FIRE tankers.)
